

UNIJA NOVA



HALF A CENTURY WITH YOU



1961

Unija Nova was founded, the first company for collecting waste glass and processing broken glass. On the whole territory of the former Yugoslavia, only industrially produced glass packaging was being collected.

1985

The first containers for separate collection of glass in public areas intended for the citizens were set up in Zagreb.



2002

The new facility with larger capacity was constructed and adapted for processing of several types of packaging waste (glass, PET, metal), as well as all types of waste glass (flat/window glass, car glass, safety glass, wire glass, hospital glassware, laboratory glassware, etc.) Own specialised software was developed for more efficient monitoring of container unloading system.

2004

Implementation of the quality control system began according to the standard ISO 9001:2008 and environmental management standard ISO 14001:2004.



2007

In the last five years the quantity of recycled glass has quadrupled, and the collection capacities have increased five times. The number of employees has increased four times, and business activity has expanded to the collection, transport, storage, processing and recycling of other types of non-hazardous waste.

2010

The business centre for Slavonija in Beketinci, Municipality of Čepin, was successfully completed and opened.



2011

Operation with goods unsuitable for further use from commercial and service activities was introduced.



2012

The existing waste management capacities were expanded - to the total of 68,000 m².



2013

The new logistic collection centres were opened in Sesvetski Kraljevec, Beketinci, Poreč, Šibenik and Dugopolje. We started handling Category 3 former food and waste edible oils.

UNIJA NOVA – TODAY



- Recycling plant specialized for recycling all types of glass and plant for waste management (total capacity of 80.000 t/yr)
- Plant for managing all types of waste packages and materials not intended for sale and/or consumption.
- Total of 68.000 m² for waste managing on three locations in Sesvetski Kraljevec and 4.500 m² on location in Slavonia.
- Five regional centres for animal by-products and derived products not intended for human consumption (EC 1069/2009) in Zagreb, Bekenici, Poreč, Dugopolje and Šibenik, with two storage facilities cooled at 4°C.
- Specialized vehicles, containers, and software for waste management.
- Company is empowered by Government's authorities for waste management
- Company is certificated for recycling of non-toxic waste according to Quality Management System EN ISO 9001:2008, Environment Management System EN ISO 14001:2004 and Occupational Health and Safety Management BS OHSAS 18001:2007.

WHAT WE DO – 1.



SPECIALISED HANDLING OF PACKAGING WASTE

- setting up containers with adequate purpose and volume at the location of waste producer
- emptying the container by specialised vehicle at the location
- checking the collected waste packaging with the submitted documentation
- processed packaging separated by key numbers is packed and sent for final processing to authorised recyclers
- as the authorised recycler of glass waste we process it for direct use in glass industry
- collection: jumbo bags, LDPE bags, bell-shaped containers 1 – 3 m³, roll-containers 15 – 40 m³
- transport: own vehicle fleet with vehicle load carrying capacity from 3.5 – 40 tons (gross)
- processing/recycling: own waste processing facility, processing capacity 80,000 t/year.






CONTROLLING PROCES FOR GLASS PACKAGING WASTE









After first control of collected waste goods they are put through the process of de-packaging and separation to different waste types, after which they are separately delivered to final recycling.




